- To develop quality benchmarks for various academic and administrative activities.

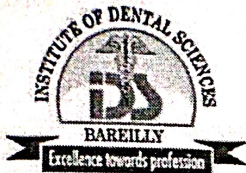

6. Infrastructure Readiness:


- A checklist was discussed to ensure campus cleanliness, signage, lab readiness, and availability of necessary ICT tools.

3. Safety Protocols for Reopening: Strict protocols were proposed, including mandatory RT-PCR tests, thermal screening, hand sanitization stations, staggered clinical schedules, and PPE kits for faculty and students.
4. Mental Health Initiatives: A counseling cell was recommended for students and staff facing stress and anxiety due to the pandemic.
5. Research Initiatives: The committee encouraged faculty to undertake research on the impact of COVID-19 on oral health, and proposals for funding were discussed.
6. Community Outreach: Awareness programs on oral hygiene during COVID-19 were planned through webinars and social media campaigns.
7. NAAC & Accreditation Compliance: Documentation for online activities and faculty training programs was emphasized to maintain accreditation readiness.
8. Future Strategies: Hybrid learning models were recommended, combining online lectures with limited in-person training.
