

### **DEPARTMENT QUALITY ASSURANCE CELL (D.Q.A.C)**

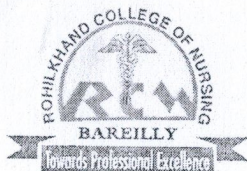
