Sub: Reservation for Foreign Students – reg.

In continuation of INC notification No. 8 of 2022 dated 05.05.2022, it is clarified, only 10% Supernumerary seats reservation for Foreign Students is permissible in all the Nursing Institutions running GNM to M.Sc. (N) program and Clinical Speciality courses having 60 or less than 60 suitable seats for GNM & B.Sc.(N) programs.

The Supernumerary seats will be 25% for the institutions who have been granted 100 or more suitable seats for GNM & B.Sc. (N) program under Section 13 & 14 of INC Act, 1947 and having 300 bedded parent hospital or more.

This will apply only to those institutions which are found suitable by Indian Nursing Council under Section 13 & 14 of INC Act, 1947.

Further this supernumerary quota of foreign students will not be filled by any other quota/general seats. The above shall be uploaded in the Nursing Admission module available under Nurses Registration and Tracking System (NRTS) in order to know the total number of foreign admissions in an academic year.
